



Thank you for making the Penticton Vees your place to host your child's birthday party.

**The package gets you the following:**

- Dedicated private Party Zone at the bottom of 105.
- Birthday child and one (1) friend will get to stand on the Vees bench for warmup and talk with Head Coach, Fred Harbinson
- Birthday child's favourite player will hand them a Vees t-shirt.

**Schedule:**

- **45 minutes before puck drop:**
  - Arrive in your section to meet with the Vee representative.
- **Warm up:**
  - A Vees Representative will take the birthday child and one (1) friend to the bench to watch warm up and speak with Coach Harbinson
- **Second Intermission:**
  - Opening presents and eating cupcakes.
- **End of game:**
  - A Vees representative will bring the birthday party down for first bumps and a meet and greet with the player.

**Please talk with your group about hockey game etiquette:**

- No running around in the arena
- Wait for a stoppage in play before leaving or returning to your seat.
- Please do not bang on or kick the back of the seat in front of you.
- No jumping over the seats
- Keep your eyes on the game as pucks could fly out of play and into the stands.
- No swearing or inappropriate gestures
- No horseplay within the arena
- Do not hang from the railings or play on the stairs

WAIVER & RELEASE

In consideration of my minor child named below being permitted to participate in activities before, during, or after the Penticton Vees Game (“Event”) at the South Okanagan Events Centre (“Venue”) on \_\_\_\_\_ which includes, but is not limited to, all on-ice activities, including games, races, and relays, I hereby agree to the following:

1. **Assumption of Risk.** I understand that my minor child’s participation in the Event involves risks of injury (including death) from many causes, including, without limitation, my minor child’s own physical condition, and the negligence of other participants in the Event, and I, on behalf of myself and/or my child, voluntarily assume and accept those risks. I acknowledge that my minor child’s participation in the Event is voluntary and may be terminated by me, my minor child, or the Released Parties at any time.

2. **Release of Liability.** I, on behalf of myself and/or my child, unconditionally release, waive all claims against, and covenant not to sue Global Spectrum, L.P. d/b/a OVG360, and the City of Penticton and each of their respective affiliates, promotional sponsors, advertisers, partners, directors, officers, officials, agents, volunteers, contractors, and employees (collectively, the “Released Parties”), from and for any and all suits, claims and demands of any kind for personal injuries (including death) and/or property damage arising in connection with my minor child’s participation in the Event and/or while on premises of the Venue in connection with the Event, including negligent rescue operations.

3. **Physical Condition.** I hereby represent that my minor child is in good health and sound physical condition, and has no physical impairments which would or could interfere with his/her performance of the activities in the Event. I, on behalf of my minor child, assume all responsibility for obtaining any physical examinations which may be indicated or advisable prior to participation in the Event, and release, waive and discharge the Released Parties from any liability, suits, claims, actions and demands of any kind whatsoever related to or arising from any decision by me and/or my child not to obtain a physical examination prior to participating in the Event. This document shall be binding upon my heirs, next of kin, executors, administrators, personal representatives, and assigns.

4. **Image Release.** I, on behalf of my minor child, hereby give permission to the Released Parties and each of their designees to take, use, reproduce and publish any and all photographs and video which may be taken of my minor child in connection with the Event (collectively, “Materials”), whether flattering or unflattering, for any purpose whatsoever, without compensation to me and/or my minor child. I also acknowledge and agree that the Released Parties will own any and all rights in such Materials in perpetuity and that I, on behalf of my minor child, waive, as to the Released Parties and its successors, assigns and licensees, all personal rights and objections to any use made of the Materials including without limitation my minor child’s name, likeness, biographical material, voice, accounts, and descriptions in advertising and promotions throughout the world including but not limited to radio, print, television, film, video, interactive media, and any other mediums now known and unknown. I, on behalf of my minor child, understand and agree that as the owner of the Materials, the Released Parties’ use of the Materials may (without limitation) extend to use by any of its sponsors, advertisers, owners, partners, affiliates, directors, officers, officials, members, and agents.

**I have read this Waiver & Release carefully and fully understand its contents. I am aware that this is an agreement not to sue the Released Parties and constitutes a complete release of liability by me and/or my minor child in favor of the Released Parties.
